FLORA LONDON MARATHON 2009 GOLDEN BOND TERMS AND CONDITIONS

I, _____, would like to take a Golden Bond place in the 2009 Flora London Marathon on behalf of Children in Crisis.

I accept that if I take one of Children in Crisis' Golden Bond places then:

1. I understand that this Golden Bond place has cost Children in Crisis £300. In order to cover the cost of my place and to support the charity's work, I agree to raise a minimum sponsorship target of £1,500 (**excluding gift aid**) for Children in Crisis.
2. I agree to pay a registration deposit of £100 (£85.11 + VAT), which will be refunded on request once I have raised £100 over the minimum sponsorship target level. No money including the deposit will be refunded for participants who do not take part in the 2009 Flora London Marathon.
3. I understand that if I am unable raise the minimum sponsorship, I am expected to make up the shortfall myself by 10th June 2009. Children in Crisis is required to report runners that do not raise the pledged amount to the Flora London Marathon race organisers as 'poor performers'. (This term is used by the London Marathon office for charity place runners who do not reach their fundraising target. Other charities will have access to these details).
4. I agree that any money raised in sponsorship in the name of Children in Crisis must be forwarded onto the charity.
5. Participants enter the Flora London Marathon at their own risk. I declare that I am in a suitable physical condition to undertake the necessary training for and participate in the marathon and I agree to seek expert medical advice if I have any health concerns prior to the race. By providing me with a Golden Bond place, Children in Crisis is in no way responsible for my fitness and ability to complete the course, or for any injuries I may sustain in training or during the race.
6. Children in Crisis or its employees do not accept responsibility for loss or damage to personal property, personal injury (or death) or any claim arising from the entrant's own actions.
